

COUNCIL PROCEEDINGS

Mayor David called the regular meeting of the Common Council of the City of Watertown to order at 7:00 p.m. on Tuesday, July 1, 2014, in the Council Chambers at City Hall.

ROLL CALL

Roll call showed the following members present: Alderpersons McFarland, Smith, Berg, Larsen, Zgonc, Coughlin, Tietz, Maron and Romlein. (9) Absent: None (0). Also present were Fire Chief Greg Michalek, Police Chief Tim Roets, City Attorney Will Gruber, City Engineer Jaynellen Holloway and City Clerk/Treasurer Cindy Rupprecht.

PLEDGE OF ALLEGIANCE

The Council recited the Pledge of Allegiance to the American flag.

MINUTES OF PRECEDING MEETING

Mayor David inquired if there were any additions or corrections to the minutes of the meeting held Tuesday, June 17, 2014. Alderperson Maron noted that none of the information regarding the first reading of the ordinances was included in the minutes. The addition to the minutes of June 17, 2014 should be as follows:

ORDINANCES

Ord. #14-17, to create Section 9.01(3)(l), Temporary Operator's License, of Chapter 9 was presented. *Sponsor: Mayor David. From: The Licensing Board.* Alderperson Maron moved for the adoption of this ordinance on its first reading, seconded by Alderperson Larsen and carried on a roll call vote. Yes – 7. No – none.

Ord. #14-18, to approve a Planned Unit Development for various Marquardt properties situated on Bayberry Drive, Hill Street, Perry Street and Hidde Drive was presented. *Sponsor: Mayor David. From: The Plan Commission.* Alderperson Berg moved for the adoption of this ordinance on its first reading, seconded by Alderperson Tietz and carried on a roll call vote. Yes – 7. No – none.

Ord. #14-19, to recreate Section 7.09(1)(z-158), Chapter 7 Traffic Code to prohibit parking on the east side of Chenango Street from the north curblineline of Hart Street, north to the end of Chenango Street, approximately 270 feet was presented. *Sponsor: Alderperson Zgonc. From: The Public Safety & Welfare Committee.* Alderperson Zgonc moved for the adoption of this ordinance on its first reading, seconded by Alderperson Romlein and carried on a roll call vote. Yes – 7. No – none.

COMMENTS AND SUGGESTIONS FROM CITIZENS PRESENT

Kim Erdmann, Executive Director of WEDO, 519 E. Main Street, was present. Kim commended the Watertown Unified School District on their second time win as National Champions in the Skills USA Program. This program has been very successful in Watertown with the Youth Apprenticeship Program and local businesses. Two of the three students, who were National winners, participated in the Youth Apprentice Program. Kim then discussed an event, which will be held on July 24, 2014 at Windwood Country Club, regarding business incubators. There will be two different speakers, Robert Hopton, who is with Idle Free Systems, an original business in one of the incubator businesses and Ronald Grayhart who oversees the UW-Whitewater Small Business Development Center. Kim reminded the Council that our incubator building has been in existence since 1993 at 1101 Industrial Drive. This has been a great way to get businesses started, which have moved into other locations within the City. All council persons and dept heads were invited to attend this event.
