COUNCIL PROCEEDINGS

Mayor John David called the regular meeting of the Common Council of the City of Watertown to order at 7:00 p.m. on Tuesday, June 20, 2017, in the Council Chambers at City Hall.

ROLL CALL

Roll call showed the following members present: Alderpersons McFarland, Berg, Larsen, Zgonc, Tietz, Maron and Kilps (7). Absent: Smith and Raether (2). Also present were Police Chief Tim Roets, Fire Chief Greg Michalek, City Engineer Jaynellen Holloway, City Attorney Will Gruber and Deputy Clerk/Treasurer Elissa Meltesen.

PLEDGE OF ALLEGIANCE

The Council recited the Pledge of Allegiance to the American flag.

MINUTES OF PRECEDING MEETING

Mayor David inquired if there were any additions or corrections to the minutes of the meeting held Tuesday, June 6, 2017. There being none, the minutes were approved as presented.

COMMENTS & SUGGESTIONS FROM CITIZENS PRESENT

Cindia Cameron of 306/308 E. Main Street spoke and expressed disappointment with the recent downtown street resurfacing and street line painting projects. Cameron indicated that no parking signs were placed during a weekend when downtown businesses needed parking and that there was black grit and paint powder residue on curbs, sidewalks and windows downtown.

COMMITTEE REPORTS

Finance Committee, June 6, 2017. 1. Review and approve budget transfer from Contingent to cover cost of IT Assessment. Clerk/Treasurer Rupprecht and the Mayor explained that this was an expected fund transfer from Contingent to the IT account. Motion was made, seconded and passed unanimously to approve this transfer. 2. Review and approve mini-van bid for Transit System. This purchase is funded 80% by the State DOT and 20% by the City. The State share is \$17,118 and the City share is \$4,280. Motion was made, seconded and passed unanimously to replace the sedan in the transit fleet with the mini-van. 3. Carlson-Dettmann Classification Review - Health Dept. Administrative Assistant. Health Officer Quest requested a pay raise for the Health Department Administrative Assistant. Carlson-Dettmann Consulting did not recommend a pay raise at this time. Following discussion, motion was made, seconded and passed unanimously to deny the request for a pay raise. 4. Review and approve request from Watertown Historical Society for City to mow lawn at Octagon House Museum. Melissa Lampe of the Historical Society was present to explain the request for assistance in keeping up the grounds at the Museum. Street Superintendent Rick Schultz stated it would cost approximately \$3,500 per year to cut the grass. He said this can be worked into the Park Department mowing schedule. Motion was made, seconded and passed unanimously to approve this request. A resolution will be presented. 5. Review and approve ambulance billing write-offs and 6. Review and approve ambulance billing hardship applicant. Motion was made, seconded and passed unanimously to lay this item over to a future meeting. 7. Review and approve budget amendment and contract with Maas Bros. Construction Co., Inc. for repair of Carnegie steps and side monuments at the Library. Library Director Peg Checkai explained only one bid was received from Maas Bros. for \$129,605 and only \$80,000 was budgeted for this work in 2017. Motion was made, seconded and passed unanimously to approve the bid from Maas Bros. with \$119,605 paid from Capital Projects Library account #05-55-11-70 and \$10,000 from Public Library Donations account #11-58-12-52. There will also be a budget transfer decreasing Annual Streets account #05-58-11-69 for \$50,706 and increasing Capital Projects Library Account #05-55-11-70 by the same amount. 8. Review and approve custodial hire. Street Superintendent Schultz presented three candidates for the position with the top candidate being

Dale Tietz. Motion was made, seconded and passed unanimously to approve this hire. <u>9. Review and approve lighting funding for Gateway Drive.</u> Street Superintendent Schultz explained the request for lights on Gateway Drive. Motion was made, seconded and approved unanimously to approve the lighting in the amount of \$4,915.60. <u>10. Review and approve Community Area Networking Study.</u> Request is for a feasibility study to see what the cost of fiber optic cable to School District and City facilities would be. Motion was made, seconded and passed unanimously to approve the City share of the feasibility study cost in the amount of \$4,750.

Public Works Commission, June 13, 2017. 1. Review sidewalk request on Lafayette Street. Motion was made, seconded and passed unanimously to have Rick Schultz and Jay Haberkorn put together estimates for sidewalk and related improvements on Lafayette Street using the Infill Sidewalk Policy for cost sharing and procedure while involving City Attorney, Will Gruber, to help get the Railroad's attention on this matter. 2. Discuss and approve landscape permit for Hoffman Drive. Motion was made, seconded and passed unanimously to refer Bethesda's request for less frequent mowing for a portion of their land to the Plan Commission. 3. Review lawn maintenance issue on S. 3rd Street. Alderperson Larsen requested to bring this issue back for an update. The DNR has concluded that basic lawn care may be performed at 1115 S 3rd Street. The City has issued notices due to lack of mowing. 4. Review and approve Compliance Maintenance Annual Report for Wastewater. Commissioners congratulated Utilities Superintendent, Kevin Freber, on a job well done. Motion was made, seconded and passed unanimously to adopt the report and send it to the State for review. 5. Review and approve selling Water Department items on Wisconsin Surplus Online. Motion was made, seconded and approved unanimously to allow the Water Department to sell items that are no longer used on the Wisconsin Surplus Online Auction. 6. Review and approve Electronics Recycling Contract with Universal Recycling Technologies. Motion was made, seconded and passed unanimously to renew the contract for electronics recycling with URT. 7. Review and approve easement for West Street. A revised resolution was presented for the easement at 864 West Street at a price of \$2,100. Motion was made, seconded and passed unanimously to approve the easement resolution. 8. Review and approve Joint Public Works and Public Safety and Welfare minutes for May 17, 2017. Motion was made, seconded and passed unanimously to approve the minutes as written.

Joint Public Works Commission/Public Safety & Welfare Committee, May 17, 2017. 1. Introductions.

Members of the Public Works Commission, Public Safety and Welfare Committee, Bicycle and Pedestrian Path Planning Task Force and City staff gave introductions. 2. Study Overview. Tim Raether gave a brief overview of the Riverside Middle School Traffic and Pedestrian Study. 3. Prioritization of City's Short Range Safety Improvements and 4. Short Range Safety Improvement Implementation Schedule. Engineer Holloway indicated parking removal in certain areas on Hall Street is already being implemented. Various suggestions for limiting parking on E. Main Street during pickup hours, a new parking lot location, reverse angle parking on Hall Street, signage and potential sidewalk installations were discussed. 5. Discuss City's Long Range Safety Improvements. Discussion was had about a proposed roundabout near the one way Middle School entrance on E. Main Street. A follow up study may be required to address feasibility of a roundabout. 6. Long Range Safety Improvement Implementation Schedule. This item will be discussed at a future date.

COMMUNICATIONS AND RECOMMENDATIONS

Susan Dascenzo of the Watertown Chamber of Commerce appeared to speak. She informed the Council that the leadership group had just wrapped up and their final project was a wage and benefit study of area businesses. Dascenzo added that it is event season for tourism. She asked that any community events for 2018 for which the date is known be reported to Robin Kaufmann as soon as possible for inclusion in statewide tourism publications. Dascenzo also described the Wild Goose and Duck Race with a magic show and movie to be held June 23.

Peg Checkai of the Watertown Public Library appeared to speak. She informed the Council that work on the Carnegie steps will likely begin on June 26. Checkai said the 110th anniversary celebration at the Library was well attended by the public and noted that Lynne Uttech had just retired from the Library. Checkai also stated that Jodi Sweeney of The Sweeney Group will be contacting the Alderpersons soon to discuss the Library's fundraising efforts which will begin in the near future.

Kristen Fish of Redevelopment Resources and Executive Director of the Watertown Redevelopment Authority appeared to update the Council on downtown plans. She stated the RDA has been busy establishing itself with a bank account, developing a web site and working on plans to get the rehab loan fund up and running. She indicated a memorandum of understanding was signed with a hotel developer and the relocation plan for affected properties has been approved by the Department of Administration. An appraiser has been chosen by the RDA to begin the appraisal process and an initial meeting is scheduled on June 21 with affected property owners and tenants.
